CHRONOLOGICAL NARRATIVE
COMBAT OPERATIONS
NOVEMBER 1944

During the month of November, the 3rd Bombardment Group (L) flew a total of five combat missions which involved forty-two sorties. A total of 36 tons of bombs were dropped on enemy installations, aircraft and supplies (1).

At the beginning of the month the Group had a total of 64 A-20's with 56 available for duty and one B-25C, one B-25D, five B-25J's, one C-47B-1 and two A-20H's. There were 94 combat crews assigned to the Group on the first day of the month with 88 of them available for combat duty. Due to the inactivity of the Group during the month the planes were kept in flying shape and most of the crews received furloughs to Australia.

The two missions of the month were centered around the western part of Dutch New Guinea. The main point of concentration was Babo and the airbases in that locality. The Japanese have been pretty well eliminated from these points.

On the first day of the month two squadrons, the 15th and 89th Squadrons, were ordered to hit the strips and vicinity near Babo. All the assigned planes reached the target area and made their bombing run across the target dropping 500 pound demolition bombs. Seventy-five per cent of them hit the target but no results were observed. Three bundles of propaganda leaflets were dropped and photographic pictures were taken of the area. The airbase showed signs of considerable activity (2).

The 3rd day, three squadrons, the 8th, 89th and 90th, were ordered to bomb and photograph the area near Babo and Utarom. The assigned planes reached the target area and dropped 500 pound demolition bombs across it. Damage could not be determined due to the dirt made from the exploding bombs (3).

The remainder of the month the Group was released for maintenance and training.

CHRONOLOGICAL NARRATIVE
ADMINISTRATION
NOVEMBER 1944

During the first part of the month of November 1944 the Third Bombardment Group was stationed at Hollandia, Dutch New Guinea, APO 565. Part of the month was spent in moving to a new location on Leyte Island in the Philippines and in setting up a new camp area. At the latter part of the month the 3rd Bombardment Group - consisting of Group Headquarters, 8th, 13th 89th and 90th Bomb Squadrons - were stationed at Dulog, Leyte Island, Philippines, APO 72. The personnel on the first day of November consisted of 192 officers and 1077 Enlisted Men. On the last day of the month there were 197 officers and 1104 enlisted men; an increase of five officers and 27 enlisted men (1).

The month of November was truly a month of inactivity as far as personnel was concerned. There were very few promotions or changes within the Group. No men were released for rotation or furlough to the States. All furloughs and leaves to Australia had been cancelled the preceding month by V Bomber Command.

On the first day of the month 2nd Lt. Snowden Steuart was attached unassigned to headquarters and his job within the organization will be assistant Statistical officer. At the end of the month he was assigned to the 3rd Bomb Group per orders from V Bomber Command (2).

Lt. Col. Richard M. Ellis was relieved as Commanding Officer of the organization and on the 2nd of November orders came through from higher headquarters permitting him to leave for the States and temporary duty to Washington D.C. (3).

Major Kenneth E. Rosebush, assistant operations officer, was relieved from assignment and duty with the organization and re-assigned to Headquarters of Fifth Air Force (4).

On the same day two new men were assigned to the organization from the 268th Replacement Company and will work with Special Services. They are Cpl. Lester J. Fisher and Pvt. James J. Johnson (5).

The 3rd day of the month Sgt. John I. Wheeler was placed on flying status with the Group (6).

Technical Sergeant Meredith Bryant and Corporal Robert Harrison went on Detached Service to Cairnes, Australia on the 4th day of November and Major Charles P. Martin went on detached service to Sydney, Australia for the purpose of helping with the publication of a Group Year Book covering events of importance during the Group's tour of duty in the war zone.

On the 6th Cpl. Kenneth King and Raymond Gossett, Pfc August Parker and Pvt. Leonard Woods were assigned to the organization from V Bomber Command and Staff Sergeant Arthur Sheppard was assigned from the 92nd Airdrome Squadron (1).

The Group moved camp on this day and proceeded to Humbolt Bay where they loaded up on LST's and proceeded to Leyte Island. 19 officers and 117 enlisted men departed camp and eight officers and 19 enlisted men remained behind on detached service.

Captain Claud McAden, T/Sgt Meredith Bryant, Sgt Lewis Janoff, Cpl Melvin Abeln and Cpl. Robert Harrison went from DS rear echelon to TD at APC 924 on the 15th of the month.

The following men were assigned to the organization from the 930 Signal Bn: M/Sgts John M. Heim, Henry E. Nelson, T/4 Max Laurie, and T/5 Dwight Baird (2).

The outfit arrived on Leyte Island on this date and set up a temporary camp on the beach.

Captain Cecil P. Jones was promoted to the rank of Major on the 27th of November (3).

On the same day Major Samuel M. Frederick and M/Sgt Henry E. Bryant were attached unassigned to the organization per VCCG, V Bomber Command.


The Group Commander during the month of November was Colonel John P. Henebry, who had just returned from DS to the United States and resumed his old position.

LOCAL INTEREST

MOVE TO THE PHILIPPINES

On the 9th of the month the 3rd Bombardment Group started its move from Hollandia, Dutch New Guinea to Leyte in the Philippine Islands. The Group had been located at Hollandia since May 12, 1944 and up to the time of its move had been hitting targets in Western and Northern New Guinea. The whole move up to and including the landing at Leyte was well planned and executed but from that day on things didn't run too smoothly.

Each department was responsible for its own equipment in loading and taking it to Humbolt Bay at Hollandia. It was all carried down to the beach via truck and placed in a convenient pile for loading it on to the LST's the following day. Four LST's were assigned to the Group, each squadron having one LST and Group Headquarters was divided up with the 8th and 13th Squadrons.

On the 10th of the month a loading detail was sent down to the two LST's on which Headquarters were to load their equipment. This detail assisted in making a ramp for the trucks to drive onto the boats without stalling in the sand. This required several hundred sand bags and the morning was spent in building the ramp. However, once the ramp was built loading went on in a hurry and the entire ship was loaded by midnight that night. Then with the personnel on board the ship sailed out to the middle of the harbor where it waited for the next day until other LST's in the convoy were loaded and ready to move out. At 1800 the convoy left Humbolt Bay and sailed north. On the morning of the 16th the convoy landed at Leyte on the beach near the town of San Roque. The Island certainly looked good after the jungles of New Guinea and the men were quite elated over the fact that the natives were out to meet the ships as they came in for a landing and they appeared quite white.

A temporary camp was set up on the beach near the village of San Roque until transportation facilities could be obtained to carry us over two small rivers to the permanent location. An LCT was chartered from the Navy and most of the heavy equipment was moved down the beach about six miles to where the permanent location was. The rest of the material was taken by trucks down to the river and then loaded on "Ducks" and ferried across the river and taken on to the camp area where it was unloaded. Most of this was done in the rain and quite a bit of the equipment got wet. However, it was soon put under cover and none of it was ruined.

The present camp is situated on the beach two or three miles south of Dulag village. Most of the office buildings, the Mess hall and the motor pool have been set up and completed and ready for operations.

PUBLIC RELATIONS RELEASE

The following is a General Release story written by Public Relations upon the 3rd Group's return to the Philippines.

FIFTH AIR FORCE, SOUTHWEST PACIFIC---Completing another link in the long chain of events, the Grim Reapers have returned to the Philippines. One of the few outfits to see action in the Philippines during the invasion by the Japs and the present invasion of the American forces in the liberation of the Islands they are ready to show the little Sons of Heaven the might of their striking power.

The hard-hitting Grim Reapers were flying B-25's at the time of their first appearance in the Philippines. Under the leadership of Colonel John H. Davies they attacked Japanese shipping and ground installations April 11 to 14, 1942, shortly after the fall of Bataan. During this action, three transports were sunk, four others were damaged, three seaplanes were shot down and docks and installations at Cebu and Davao were damaged extensively. In addition to all this the B-25's brought out of the Philippines twenty-five officers and enlisted men, newspaper correspondents and a liaison officer of the Chinese Army.

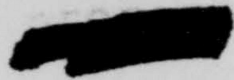
This mission was accomplished from Australia over thousands of miles of enemy-controlled seas. In all the planes flew a total of 70,000 miles in three days. Extensive damage was done in spite of attacks from enemy aircraft and intensive and accurate ack ack from heavily-defended ground positions and warship batteries.

The successful mission was a stimulant to the lagging spirits of the United Nations, at low ebb then because of the fall of Bataan. The hard blows by the B-25's of the famed Grim Reapers proved the fight for freedom was still being made.

Since those early days of the war and the humiliating defeat at Bataan, the Grim Reapers have made an enviable record for themselves. In the Bismarck Sea Battle this outfit proved for all light and medium bombardment units of the Army Air Forces the devastating results that could be obtained from low-level attacks. The Presidential Citation has been awarded for the successful work done in the Papuan Campaign. Important missions accomplished by this unit include Lae, Rabaul, Hollandia and Western Dutch New Guinea.

The Grim Reapers, now completely converted over to A-20's, Boston attack bombers, have accounted for the destruction of 477 enemy aircraft and sinking of 298 enemy vessels, an enviable record for any unit of the Army Air Forces.

There is still a long ways to go before the ultimate goal will be achieved but the Grim Reapers will be in there reaping their harvest to the end. The men who fought and died at Corrigidor and Bataan will be avenged!




